Ethics Complaints filed Against Texas Legislators

Ethics complaints were filed against the below named Texas State Senators and/or House members with the Texas Ethics Commission on Feb. 25, 2008. Verbatim copies of the complaints can be found in alphabetical order below.

The only difference between the actual complaints filed with the Commission and what you'll see below are the inclusion of appropriate images and/or photos, which are designed to highlight the frivolity of the stated misconduct.

In addition to the filing with the Ethics Commission, ethics complaints were also filed at the same time with the local grievance committee of the Texas State Bar regarding the attorneys named herein. Out of the 16 complaints filed in this initial filing, nine (9) of the miscreants are attorneys. Are you surprised? 

§254.031 of Title 15 of the Election Code – General Contents of Reports (campaign expense) states:

- (a) Except as otherwise provided by this chapter, each report filed under this chapter must include:
- (3) the amount of political expenditures that in the aggregate exceed \$50 and that are made during the reporting period, the full name and address of the persons to whom the expenditures are made, and the dates **and purposes of the expenditures**.

Due to the fact that Jesse failed to comply with the requirement that he provide the "purpose" of 66 expenses paid to Southwest Airlines and his prior conduct in illegally billing for commuting purposes, it would appear that that the below expenses may well be for commuting purposes.

There can be no dispute that Linda violated the law by using campaign funds to pay for food and undisclosed "supplies" for her Austin apartment from 2003 through Dec. 2006. Moreover, her conduct in failing to disclose the purpose for 45 purchases of "food" and "supplies" Jan. 2005 through July 2007 would clearly indicate that many of these expenditures were for unlawful payment for Austin apartment supplies/food.

Linda also failed to provide and detail as to the "purpose" of numerous (118) expenditures to purchase books, gifts and lodging, which also violates Texas reporting laws.





What an ingrate, and a lazy one at that if there ever was one.

Time Warner Cable Services for Austin Apt.

1. 2007 = \$1,980.43 = monthly average of \$165.00

In reviewing Time Warner's website regarding costs in Austin, it would appear that Phil purchased the "Get it All" service that includes (a) digital phone, (b) Road Runner Internet access, (c) DigiPic 4000, and (d) Starz movie channels, which costs \$159.95 per month. Since Phil's monthly average is \$165, he must have also ordered a sports channel or maybe even the Playboy Channel.

Regardless of what Phil ordered, I can't imagine that such lavish expenditures could be construed as being a "reasonable household expense" while residing in Austin during legislative sessions. Due to the fact that the 80th legislative session began on Jan. 9 and ended on May 28, 2007, how is it reasonable for Phil to pay \$165 a month for cable for his Austin apartment from June through Dec.? Clearly, this cannot be determined to be a reasonable living expense!

Mobile Phone Charges for 2007

The "digital phone" service Phil received from Time Warner provides unlimited long distance calls. Despite this free service, Phil paid \$3,562.35 to AT&T Mobility and \$7,279.15 to Cingular Wireless for a total of \$10,841.50 in 2007.

It would be hard to believe that of the \$10,841 in cell phone bills for 2007 that, none of them were of a personal nature. This is especially true when taking into consideration the fact that Phil was provided with unlimited long distance calls with Time Warner.

Ethics Advisory Opinion No. 104 – Whether an officeholder may use political contributions to pay dry cleaning and laundry bills. (AOR-98) This EAO states in the summary: "Legislators may not use political contributions to pay laundry and dry cleaning expenses incurred in Austin.



Ethics Advisory Opinion No. 241 – "Whether a legislator may use political contributions to pay various expenses." This EAO defines "personal use" as one that "primarily furthers individual or family purposes not connected with the performance of duties or activities as a candidate for or holder of a public office."

It goes on to state: Personal use" does not, however, include: payments made to defray ordinary and necessary expenses incurred, including rent, utility and other reasonable housing or household expenses incurred in maintaining a residence in Travis County. Under the subheading "Meals" it states: "We do not interpret the 'household expense' exception to extend to

the cost of meals in Austin. We think the exception is meant to cover costs associated with the necessity of maintaining a second residence in the Austin area. In contrast, the legislator would incur meal costs whether or not he was required to reside in Austin."

Ms. Oliveira unlawfully utilized campaign funds to pay for (a) dry cleaning, (b) groceries (c) food, (d) laundry, and (e) beverages for Austin apartment, etc.
