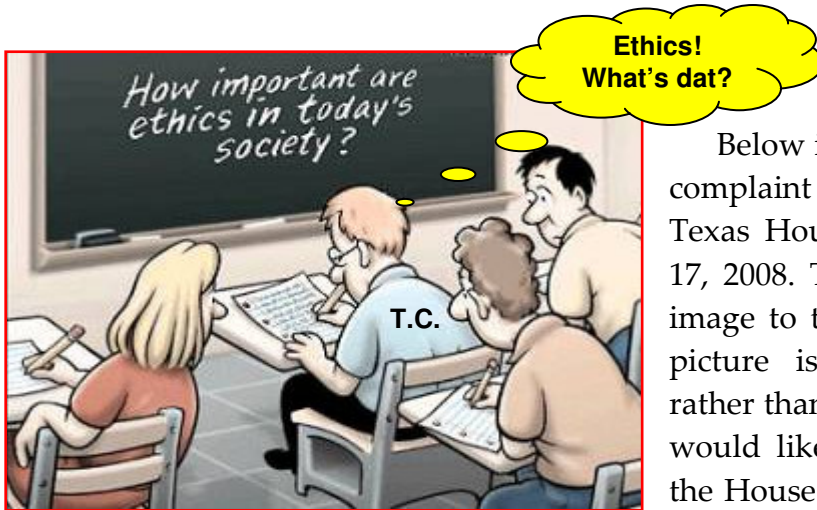


# **Tom Craddick**

## **Ethical Lepercon**



Below is a verbatim copy of an ethics complaint filed against Speaker of the Texas House, Tom Craddick on March 17, 2008. The only difference being the image to the left. I decided to use it (a picture is worth a hundred words) rather than engage in editorializing. One would like to think that as Speaker of the House that, Tommy would have led

by example. Unfortunately, in addition to being a serial violator of the ethics laws, Tom also gives “nepotism” a bad name. Recent news stories about Tommy (Dallas Morning News, Houston Chronicle, etc.) clearly indicate that he is vindictive, arrogant and lacks any scruples. This is of course a dangerous combination when dealing with political hacks.

### **Tom Craddick – Rep. 82<sup>nd</sup> District – Midland**

#### **Violation of Title 15 – Election Code – Sec. 253.035**

**EXPN, 207, ENT, Aspen Executive Air, 320 W Main St., Aspen, CO, 20060915, 13,513.40, Houston, Attend Rep. Glenda Dawson’s funeral**

#### **Airfare for Tom and Nadine to attend funeral**

First and foremost, I do not believe that attending a funeral can be construed as an official officeholder and/or campaign function. Clearly, Craddick and/or anyone similarly situated could have chosen to not appear and merely sent flowers. Therefore, it would appear that this was a personal expenditure.

With that said, there are several problems with Craddick’s expenditure of \$13,513.40 for him and his wife to fly to Aspen to “attend Rep. Glenda Dawson’s funeral.” The

possible scenarios involving this expense are set forth below. Regardless of which one is true, it would appear that campaign funds were used for personal purposes and/or such conduct fails to meet the reasonableness standard for expending campaign funds.

### **Scenario No. 1**

There is no dispute that Rep. Glenda Dawson's funeral and internment took place in Pearland, Texas on Sept. 15, 2006. This fact can be confirmed by a review of news stories and/or by visiting [www.cemetery.state.tx.us/pub/userform.asp?step=1&persid=10840](http://www.cemetery.state.tx.us/pub/userform.asp?step=1&persid=10840) on the Internet. Therefore, if Craddick is claiming that he flew to Aspen for said funeral, then said claim is a total fabrication.

### **Scenario No. 2**

It may well be that Craddick and his wife were vacationing in Aspen on the 12<sup>th</sup> of September when Ms. Dawson died (she died in the afternoon). Due to Craddick's exalted position as Speaker of the House, and because Ms. Dawson was a fellow Republican, it must be presumed that he was made aware of Ms. Dawson's death on the 12<sup>th</sup> and/or no later than the morning of the 13<sup>th</sup>.

A review of Craddick's expense forms just prior to and just after the 12<sup>th</sup> (11<sup>th</sup>-17<sup>th</sup>) discloses that on the 11<sup>th</sup> he appears to have been staying in a Hotel in Dallas. There are no other expenditures of any kind from the 12<sup>th</sup> through the 17<sup>th</sup>.

Assuming that Craddick was vacationing in Aspen on the 12<sup>th</sup>, and further assuming that he decided on the 12<sup>th</sup> that he would attend Dawson's funeral, he had three (3) days or at least 68 hours to travel from Aspen to Houston. He could have accomplished this task by any of the following means:

- Paid \$800 to Snowmass Eagle Transport in Aspen (877-925-5549) to be taken to the Denver Airport ([www.aspensnowmasslimo.com](http://www.aspensnowmasslimo.com)) (Circa: 03/13/2008)
- Purchased 2 airline tickets from Denver to Houston for about \$1500 ([www.cheapflights.com](http://www.cheapflights.com))
- **Total cost of around \$2,300**
  
- Avis in Denver (303-839-1280) charges \$144 a day (unlimited mileage) to rent a mid-size car for a one-way trip from Denver to Houston for a total cost w/fuel of about \$500 (Circa: 03/13/2008)
- \$800 to Snowmass Transport to get to Denver
- 1107 miles – Denver to Houston ([www.mapquest.com](http://www.mapquest.com)) – 21 hour drive
- **Total cost w/meals of around \$1,500 and he could have left Aspen as late as 6:00 a.m. on the 14<sup>th</sup> and arrived in Houston at noon**

The payment of \$13,513.40 to Aspen Executive Air appears to be for a roundtrip flight from Aspen to Houston and then back to Aspen. The following facts are offered to support this conclusion:

A review of New Flight Charter's website ([www.newflightcharters.com](http://www.newflightcharters.com)) discloses:

- One-way charter flight from Denver to San Diego costs \$5,900
- One-way charter flight from Denver to LA costs \$6,900

A review of air miles at [www.airtimetable.com](http://www.airtimetable.com) discloses:

- 872.70 air miles – Denver to Houston
- 851.04 air miles – Denver to San Diego
- 837.83 air miles – Denver to LA

The above facts would lead a reasonable person to conclude that the \$13,513.40 Craddick paid to Aspen Air involved charges for a roundtrip to Houston. Since it appears that Craddick and his wife were on vacation (if it was state business, there would be charges to the campaign; however there aren't any).

No matter how you toss the dice, it is clear that the entire \$13,513 was personal or at a minimum the flight back to Aspen (\$6,756) was clearly personal in that said expense was for the sole purpose of flying Tom and Nadine back to Aspen so they could enjoy the balance of their vacation.

## Travel expenses paid for Nadine Craddick

### **Violation of Title 15 – Election Code – Sec. 253.035**

On several occasions Craddick used campaign funds to pay for trips by his wife Nadine. A review of Craddick's website, etc. does not reveal that Nadine is employed by and/or works in any capacity for Craddick's office or his campaign. Therefore, it certainly appears that the following campaign expenses paid on behalf of Nadine were of a personal nature.

### **June 2007 trip to Vilnius Lithuania**

Craddick's campaign paid \$1800 in airfare for Nadine to fly to Lithuania; however, the expense is only defined as "State Legislative Leaders Foundation Conference." Obviously, Nadine ain't a state legislator. Moreover, I searched websites in Lithuania and the Legislative Leaders Conference and was unable to discover any such event.

Even if such an event was held, this surely appears to be a personal expense since Nadine went by herself and is not a member of any State agency that I'm aware of. The expenses are listed below.

#### Dec. 2007 trip to DC

Craddick's campaign paid \$357.40 for airfare and \$1,068.00 for lodging for Nadine's trip to DC, which is described as "meetings to discuss state business." If Nadine wants to discuss state business I don't believe that Craddick can use campaign funds for this purpose. She's not a State employee! Just because she's the wife of the Speaker of the House is of no consequence and doesn't place Tom in a position to thumb his nose at the Ethics Laws. The expenditures are listed below.

### Wages paid to Christi Craddick

Now whether or not Craddick's employment of his daughter Christi runs afoul of the Texas Nepotism laws I do not know. However, the facts below clearly demonstrate that something is amiss. Put simply, it doesn't pass the proverbial smell test! Moreover, it is

a given that one cannot dispense campaign funds to any service provider if valuable services are not in fact provided.

Prior to Craddick's ascension to Speaker of the House (Jan. 2003), Christi never received a nickel from his campaign. However, once chosen as Speaker, Christi magically appears as a high paid employee. She was paid as follows:

- ▶ 2007 – paid \$133,075.20 = \$11,083 per month
- ▶ 2006 – paid \$125,764.87 = \$10,480 per month
- ▶ 2005 – paid \$108,597.61 = \$9,050 per month
- ▶ 2004 – paid \$91,769.82 = \$7,647 per month
- ▶ 2003 – paid \$98,000 = \$8,167 per month
- ▶ **Grand total \$557,207.50**

During this same period of time (Jan 2003-Dec 2007) Craddick paid \$271,348.97 in wages to twenty-three (23) different employees, some of which appear to have been interns. Long term employees were paid as follows:

- ▶ Rebecca Young = \$38,105.74 – Jan. 2003-Dec. 2006
- ▶ Susan Wynn = \$72,411.84 – Dec. 2002-Dec. 2007
- ▶ Julie Bammel = \$13,644.69 – Jan. 2003-July 2006
- ▶ Nancy Fischer = \$21,150.50 – July 2004-Dec. 2007
- ▶ Robert Richter = \$22,568.24 – Jan. 2003-Dec.2004
- ▶ Gail Nona-McCall = \$21,397.77 – Jan. 2004-Aug. 2007

Christi's starting salary in 2003 was \$8,000 a month. As of Dec. 2007 her salary increased to \$11,040 a month, which amounts to a 37.5% wage increase. Now, lets compare Christi's wage increases to the above named long term employees.

- ▶ Young \$833.33 Jan. 2003 – reduced to \$707.07 in Jan. 2004 (15% decrease)
- ▶ Wynn \$1,000 in Dec. 2002 - Jan. 2004 reduced to \$890.17 (11% decrease)
- ▶ Bammel \$333.33 in Jan. 2003 – Jan. 2004 reduced to \$307.86 (7.6% decrease)
- ▶ Richter \$833.33 in Jan. 2003 – Jan. 2004 reduced to \$769.58 (7.6% decrease)
- ▶ McCall - \$461.75 Jan. 2004-Aug. 2007 (no increases)

It is rather difficult to believe that Christi is actually worth over \$11,000 a month and/or that she actually provides services that would justify such a wage. In fact, during my review of several hundred legislators' campaign expenses online I could not discover another person that paid such an outlandish salary.

In fact, a comparison of the same type of expenditures by Speaker James (Pete) Laney, Craddick's predecessor, shows that he spent \$83,600 in 2002 for nine (9) employees, several of whom were interns. The most Laney paid was \$37,400 (\$3117 a month) to Mark Thompson. The very next years, Craddick paid Christi \$98,000 which is nearly

\$15,000 more than Laney paid for his entire staff. To suggest that Christi was worth more in 2003 than Laney's entire staff was in 2002 is laughable at best.

### Travel Expenses paid to Christi Craddick

On the following occasions campaign funds were used to pay for travel expenses for Christi to attend ALEC conferences in San Francisco and Philadelphia. Since Christi is not disclosed on any campaign report as the "treasurer," etc. I fail to see how these expenses are legitimate. They clearly look like paid vacations approved by Dad at the expense of campaign contributors.

### Airfare expenses – no purpose disclosed = \$43,178.38

**§254.031 of Title 15 of the Election Code** – General Contents of Reports (campaign expense) states:

(a) Except as otherwise provided by this chapter, each report filed under this chapter must include:

- (3) the amount of political expenditures that in the aggregate exceed \$50 and that are made during the reporting period, the full name and address of the persons to whom the expenditures are made, and the dates ***and purposes of the expenditures***.

In regards to the 195 entries set forth in the tables below, the only explanation as to "purpose," Craddick merely states "travel." This generic term (don't all airlines provide travel?) does not comply with the reporting laws because it fails to disclose what the specific purpose of the flight was. Describing airfare expenditure as "travel" is analogous to making repeated purchases at Reddy Ice Holdings in Dallas and then describing the purchase as "ice."

**§254.031 of Title 15 of the Election Code** – General Contents of Reports (campaign expense)

Again we have Craddick failing to provide any detail as to the purpose of the 45 expenditures listed in the table below. He merely states “lodging,” which isn’t very enlightening to say the least and clearly violates the reporting laws requiring that the purpose of said lodging be disclosed.

**§254.031 of Title 15 of the Election Code** – General Contents of Reports (campaign expense)

Here’s yet another example of Craddick failing to provide any detail as to the purpose of the 198 expenditures (it’s probably much higher since some expenditures exceed \$4,000). All he provides after each expense is “flowers.” Of course the law requires him to disclose the “why and the who” in regards to these expenditures, which he utterly failed to do.
